44 W Main St. New Kingston: There has been no activity. Lou Martin made a motion to determine the property blighted as noted in Blight Determination Resolution No. 3-2023. Diane Voda seconded. The motion carried.

6883 Wertzville Rd. Enola: There has been no activity. Vince DiFilippio made a motion to determine the property blighted as noted in Blight Determination Resolution No. 4-2023. Lou Martin seconded. The motion carried.
