The Housing Authority Board Meeting was called to order by Chairman M. Bishop at 12:00 pm.

Roll call – Roll call was taken, and we had a quorum.

Chairman Bishop stated that a Housing Authority Executive session was held on October 16, 2025, at 11:30 am to 11:55 am to discuss potential legal action. No action was taken.

Public Comment - None

Approval of Minutes from September 18, 2025 – M. Palmer made a motion to approve the Housing Authority Board Meeting Minutes from September 18, 2025, second by D. Kelly. Motion carried.

List of Expenditures for September 2025- K. Kessler advised that the monthly List of Expenditures for September 2025 were routine monthly expenses except for the expense of \$33,959.68 for Fluss Flooring which was for the replacement of floors in units that are vacant. D. Kelly made a motion to approve the List of Expenditures for September 2025 as presented, second by M. Palmer. Motion carried.

Reports of the Treasurer – K. Kessler reviewed some notable expenses for Public Family. Under Contracts and Agreements expense for the new IT Company, Kirbtech, contract, Repairs & Maintenance expense for new flooring for units, a piece of new equipment and work on HCVAC in a tenant unit. The Bad Debt is write-off for past due rents which were approved last month by the Board. Public Senior Housing had a higher dwelling rental income due to staff collecting late/past due rents, Contracts & Agreements show expense for the new IT contract, Bad Debt is write-off for past due rents which were approved last month by the Board, Tenant services show the expense of purchasing shopping carts, and Repairs & Maintenance has expense for flooring in units.

Management Reports - Executive Director – None, due to M. Kuna on Maternity Leave.

Section 8 Housing Choice Voucher Report – B. Shull stated Section 8 Housing Choice Voucher is holding steady. She advised the Board we were informed that HAP for November and December has been loaded, and we can draw it down.

Report of Treasurer – K. Kessler reviewed the Administration Income Statement for September 2025 with the Board. Overall, we show a net income over Budget for September 2025 and year-to-date 2025.

Management Reports – Executive Director – None, due to M. Kuna on Maternity leave.

Community Development Report – M. Kitchen stated they held a second CDBG Open House on October 15th. Staff are working with Hope House to finalize their HOME loan for \$500,000.

Blighted Property Reinvestment Board - Property at 1245 Harrisburg Pike will complete the blight process on October 16 at the Cumberland County Planning Commission meeting to approve and refer to the Redevelopment Authority for action.

Whole Home Repairs Program – Staff have completed 26 home repair projects and have nine currently in progress.

Staff sent out Municipal redevelopment toolkits to each municipality in Cumberland County.

Tax Credit Housing Management Report – B. Shull said staff was pulling from the waiting list to try to fill the vacancies at American House, Enola Chapel and Newport Square. We are still advertising for businesses to rent the commercial space at Newport Square.

Federal Senior Housing – B. Shall gave a brief update on the property. There were three (3) terminations in September, one (1) move-in, four (4) new leases. Staff are currently working to increase the number of applicants on their waiting list.
